Operational Readiness for E-Commerce

The ORE Meeting was held at Nadi Fiji and was inaugurated along with another UPU UPU sub-regional meeting important policy issues and regional workshop on postal financial services development and UPU trademark implementation in the Pacific region. The Director General, Mr. Bishar Hussein, presided over the opening ceremony and delivered an opening speech. The Permanent Secretary for Public Enterprises of Fiji government, Mr. Jitendra Singh, addressed a keynote and welcomed all participants. There were a total of 20 participants from all 9 developing countries of the Pacific region, namely Fiji, Kiribati, Nauru, Papua New Guinea, Samoa, Solomon Islands, Tonga, Tuvalu and Vanuatu, participated in this workshop.

The meeting was chaired by H.E. Mr. Hossein Nemati, Vice Minister and Chairman Post Company of Iran. The Meeting was participated by 25 out of 32 APPU member countries. There were 122 delegates in total.

The key topics deliberated at the EC covered APPU/ UPU Reform, activities of the College and developments and issues to be discussed at the UPU

Extraordinary Congress in Adis Ababa, among others. The next APPU EC Meeting will be convened in Tokyo, Japan, tentatively in September 2019. The planned activities of the various Working Groups and Committees were presented for the coming years.
