- > The main objectives are to help Dos
  - Modernize operational processes and use all available IT standardized tools and E2E systems to implement operational solutions so as to meet e-commerce requirements
  - Contribute to the further growth of the e-commerce market by
    - Enhancing the E2E reliable delivery performance
    - Providing consumers with more visibility through EDI message exchanges, more customer-oriented solutions

# Multi-year integrated projects

- Regional project for postal development of least developed countries (LDCs) in the Asia-Pacific region
- ➤ Budget for each country: 60,000 CHF
- ➤ Completed activities (2017-2020)
  - Procurement of equipment
  - Provision of consultancy services
  - Provision of individual fellowships for training at APPC
  - Provision of fellowships for group training at APPC or in their own countries



# Covid-19 related projects

- Provide DOs of LDC personal protective equipment (PPE) to combat Covid-19 (2020)
  - UPU budget: 150,000 CHF
  - China Special Fund: 150,000 CHF
  - France Special Fund: 150,000 CHF
  - Japan Fund: 100,000 CHF
  - Swiss Special Fund: 10,000 CHF
- Support designated operators to improve their mail delivery following COVID-19 Pandemic under UPU's Recovery Plan (2021)
  - Beneficiaries: 19 DOs from LDCs, SIDSs and LLDCs
  - Fund from UPU, France and Japan



# South-South & triangular cooperation

### **Contribution during 2017-2020 cycle**

- ➤ Japan fund (50,000 CHF)
  - Project: Strengthen the postal sector to fulfil its social obligation
  - Beneficiaries: Bhutan, Fiji, Maldives
- ➤ China fund (78,400 CHF)
  - APPC training fellowships for all Asian LDCs
- Korea PC donation (200 sets)
  - Beneficiaries: DOs of Pacific countries
- ➤ La Poste France Fund (12,400 CHF)
  - Postal development in Afghanistan (Project document under preparation)



# South-South & triangular cooperation

# QSF projects

- ➤ The Asia Pacific region is the region with the highest available funds for project management
  - 22 beneficiary DOs
  - 36 projects with a total budget of 14 million USD
- ➤ The Asia Pacific region is the most active region in terms of project implementation. It is also the region which has seen phenomenal growth in e-commerce and therefore, many projects involve supply chain elements such as Customs and Security, parcel lockers and green vehicles



# QSF common fund projects

- > The Common Fund marks a significant milestone for QSF and it should continue to develop into a stable and sustainable funding platform for the UPU
- ➤ The Common Fund has helped a number of DOs to implement EAD objectives via the deployment of CDS and data capture solutions such as EAD Mobile App and CDS kiosks
- ➤ Electronic advance data (EAD) capture, transmission and compliance project (2020)
  - The main aim of this project is to enable the DOs to capture, transmit and attain compliance with UPU EAD requirements ahead of the upcoming regulatory deadline in January 2021
  - Most DOs of developing countries are entitled to this project
  - 31 DOs have participated in this project
  - Procurement of postal equipment for some DOs has been completed



# Security projects

- ➤ Joint UPU-WCO postal security capacity building project: countering transportation of dangerous contraband (sponsored by USPS)
  - Workshop for Asia Pacific conducted at APPC (June 2019)
- Postal security pilot audit and certification for Solomon Islands and Vanuatu conducted (August 2019)
- UPU postal security expert reviewer remote workshop conducted in November 2020
- > Remote security certification in 2021
  - Myanmar
  - Thailand
