India Post is the largest postal network in the world and a significant contributor to the UPU.

India also voluntarily contributes significantly towards various initiatives and capacity-building activities in the postal sector globally with special focus on the Asia Pacific Region.

As a board member of the Quality of Service Fund (QSF), India oversees project approvals and supports other countries with QSF projects.
