

Committee 1 (Governance and Management of the Union)

Co-Chairs (Kenya and Spain) presented the main topics:

 - Public-private partnerships.

Co-Chairs (Uruguay and Zambia) highlighted:


- UPU Strategy Implementation Report

Task force on the Opening Up of the UPU to wider Postal Sector Players

- The Co-Chairs (Algeria and the United States of America) presented progress:
- The work of the task force would be broken down into three workstreams:
 - i) The institutional framework,
 - ii) UPU products and services and
 - iii) Reform as a continuum.
- It was proposed that the technical review of UPU products and services under workstream 2 be delegated to CA C 2.
