Purpose

The Asian-Pacific Postal Union (APPU) will hold its Executive Council meeting on 14-18 August 2023, where a dedicated session will discuss the upcoming 4th Extraordinary Congress of the Universal Postal Union (UPU) on opening up the UPU to wider postal sector players and other urgent postal issues.

The Asia Pacific is a diverse region with differing levels of postal capacity. It is the heart of e-commerce, where an estimated 26% of global cross-border e-commerce occurs and a further 50% involves the region. The Extraordinary Congress presents further opportunities for governments, postal operators, and citizens.

The Executive Council will discuss regional perspectives on the Extraordinary Congress proposals and seek to negotiate regional consensus or principles that can enhance the outcome achieved for all members.

To assist with preparations, a virtual briefing from subject matter experts will be held to inform APPU members of the proposals and answer questions. Member countries are then invited to consider the proposals and bring their perspective to the APPU Executive Council to contribute to regional discussion.
