





Proposed APPU Structure 2022 – 2026




Outline for WGs meetings at the 13th APPU Congress

- Be aware of how your WG can blend its activity with the APP and APPC so that the Union works cohesively and to a common purpose.




Procedure for membership and chairmanship of the WGs

- In terms of chairmanship of the WGs, the Bureau will send another nomination form to members this week. Please reply by 1 July.




Selection Process for the Finance Committee 2022 – 2026

- Members can nominate the membership and chairmanship of the FC;
- the Bureau will choose, from the nominated members, 5-7 members geographically;
- the EC Chair (Thailand) and the Bureau will choose, from the nominated members, the Chair of the FC; and
- the membership and the chairmanship will be reported and adopted by the first Plenary of the Congress.




Credentials Committee

- The Committee comprises 2-3 member countries
- Member countries nominate a representative(s) with excellent English
- The Committee needs to be aware of the proposed changes to the RoP regarding credentials




Credentials Committee

- The Committee needs to be aware of the proxy variation for online-only participants who wish to have a physically-present member cast their ballot
- The Committee will need to ensure that when proxy votes are being cast, the online-only members are disconnected from the Congress
- The Committee exists only for the Congress
- The Bureau will assist the Committee during the Congress
- Nomination and selection will follow the same process as for the Finance Committee




Drafting Committee

- Traditionally, the host country has been offered leadership of the Drafting Committee
- The Committee comprises 3-4 member countries
- Member countries nominate a representative(s) with excellent English
- The Committee exists only for the Congress
- The Bureau will assist the Committee during the Congress
- Nomination and selection will follow the same process as for the Finance Committee


