2. ZOOM SCHEDULE

The Zoom link will open for online delegates to join from 2 - 4 September 2026, starting at 08:30 hrs (Bangkok time).

Online delegates are requested to log in to Zoom on 2 September before 09:00 hrs.

Please note that online delegates will be admitted to the Congress only after the Rules of Procedure of the Congress have been approved, which is expected to take place at approximately 09:30 hrs.

3. DISPLAY NAME FORMAT

For security and identification purposes, all online delegates are required to use the following format for their Zoom display name:

Country Name – Delegate Name

Example: Thailand – Kwanjai

4. REQUEST FOR SPEAKING

Online delegates are requested to keep their microphones muted upon joining the meeting and throughout the meeting unless they are invited to speak.

Please note that only those delegates will be recognized whose names are included in the credentials documents of the respective countries and who are given the authority to speak during the Congress representing the country, as per the information contained in the credentials document.

If you wish to speak, please use the “Raise Hand” feature in Zoom. Once recognized by the Chair, please unmute your microphone and proceed with your questions/comments. After speaking, please mute your microphone again.

5. RECORDING

Please note that the Zoom meeting will be recorded for administrative purposes and for the preparation of the minutes of the meeting.
